



1. Introduction

Steelcon Slovakia s.r.o. is a long-standing producer of steel chimneys and steel structures including activities of design, manufacture, on-site installation, inspection, and repair services for steel chimneys and steel structures. with over 7,000 projects executed to date. Through this extensive experience, we have developed proprietary know-how, including advanced design innovations, internally developed software tools, and an integrated quality system. This system is designed to minimize non-conformities throughout the entire process — from the inspection of incoming materials to the delivery and erection of the final product at the customer's site.

Our quality management system is founded on sustainability principles and the protection of employee health. It is structured to clearly define responsibilities, support consistent execution, and drive continual improvement.

This Quality Manual defines the Quality and Environmental Management System (QEMS) of Steelcon Slovakia s.r.o., ensuring compliance with EN 1090-2 up to Execution Class 4, with routine application of Execution Classes 2 and 3. It also integrates requirements of ISO 13084-7, ISO 9001, ISO 14001, and ISO 45001. The manual outlines structured processes, describes responsibilities, and provides a framework for maintaining consistent quality in the execution of steel structures, ensuring all customer, legal, and regulatory obligations are met.

This manual describes the quality management system step by step and explains the division of responsibilities for its control. It is based on sustainability principles and a system for protecting workers.

The Quality and Environmental Management System (QEMS) of Steelcon Slovakia s.r.o. defines the framework, responsibilities, processes, and resources necessary to ensure the consistent quality of products and services, environmental sustainability, and occupational health and safety in accordance with integrated standards.

The QEMS applies to all activities carried out by company:

- Design and structural analysis of steel chimneys and steel structures
- Manufacture and assembly of components
- On-site installation and erection of steel structures
- Inspection, testing, and quality control, including NDT processes
- Repair, maintenance, and refurbishment services
- Procurement of materials and subcontracted services
- Management of environmental impacts and occupational health and safety risk

The QEMS fully complies with the requirements of ISO 9001:2015; however, the following exclusions apply:

■ ISO 9001:2015, Clause 8.3 – Design and Development: Steelcon Slovakia does not carry out independent product research & development unrelated to customer orders. Design activities are executed strictly based on client specifications and Eurocode/EN 1090-2 requirements. No other exclusions apply.
